

Archpoint Implant Dentistry – Patient Appreciation Sweepstakes

These Official Rules govern the Archpoint Implant Dentistry “Patient Appreciation Sweepstakes” (the “Sweepstakes”). Participation in the Sweepstakes constitutes full and unconditional agreement to, and acceptance of, these Official Rules.

1. **ELIGIBILITY:** Open only to legal residents of Texas, age 18 or older, who are existing patients of Archpoint Implant Dentistry as of the time of referral.
